Pennsylvania State Police. 11 (b) Duty of Pennsylvania State Police. --12 * * * 13 14 In the event of electronic failure, scheduled 15 computer downtime or similar event beyond the control of the 16 Pennsylvania State Police, the Pennsylvania State Police shall immediately notify the requesting licensee of the 17

- 16 <u>completion of an instantaneous records check if there is a</u>
- failure or similar event and either of the following applies:
- 18 (i) The purchaser presents a valid Pennsylvania
- 19 license to carry a firearm.
- 20 (ii) The failure or similar event lasts for a period
- exceeding 48 hours.
