AN ACT

1 2 3	Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in inchoate crimes, prohibiting the possession of firearm at polling place.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Title 18 of the Pennsylvania Consolidated
7	Statutes is amended by adding a section to read:
8	§ 914. Possession of firearm at polling place.
9	(a) Offense defined Except as provided under subsections
10	(c) and (d)(2), a person commits an offense if the person:
11	(1) knowingly possesses a firearm in any building, real
12	property or parking area of a polling place holding an
13	election;
14	(2) knowingly possesses a firearm in any building, real
15	property or parking area of a polling place holding an
16	election with the intent of using the firearm in the
17	commission of a crime; or

- 1 (3) knowingly causes a firearm to be used in the
- 2 commission of a crime in any building, real property or
- 3 parking area of a polling place holding an election.
- 4 (b) Grading. -- The following apply:
- 5 (1) An offense committed under subsection (a) (1) shall
- 6 constitute a misdemeanor of the third degree.
- 7 (2) An offense committed under subsection (a) (2) or (3)
- 8 <u>shall constitute a misdemeanor of the first degree.</u>
- 9 (c) Exceptions. -- Subsection (a) shall not apply to the
- 10 lawful performance of official duties by an officer, agent or
- 11 <u>employee of the Federal Government, the Commonwealth or a</u>
- 12 political subdivision of the Commonwealth who is authorized to
- 13 <u>engage in or supervise the prevention, detection, investigation</u>
- 14 or prosecution of any violation of law.
- 15 (d) Posting of notice. -- The following apply:
- 16 (1) Notice of the provisions of subsections (a), (b) and
- 17 (c) shall be posted conspicuously at each public entrance of
- 18 a building where a polling place is located during an
- 19 election.
- 20 (2) A person shall not be convicted of an offense under
- 21 <u>subsection (a)(1) or (2) if the polling place fails to meet</u>
- 22 the notice requirements under paragraph (1).
- 23 (e) Definitions.--As used in this section, the following
- 24 words and phrases shall have the meanings given to them in this
- 25 <u>subsection unless the context clearly indicates otherwise:</u>
- 26 "Election." A general, municipal, special or primary
- 27 <u>election as authorized under the act of June 3, 1937 (P.L.1333,</u>
- 28 No.320), known as the Pennsylvania Election Code.
- 29 "Firearm." Any weapon, including a starter gun, which will
- 30 or is designed to expel a projectile or projectiles by the

- 1 action of an explosion, expansion of gas or escape of gas. The
- 2 term does not include any device designed or used exclusively
- 3 for the firing of stud cartridges, explosive rivets or similar
- 4 <u>industrial ammunition</u>.
- 5 "Polling place." The room provided in each election district
- 6 for voting during an election.
- 7 Section 2. This act shall take effect in 60 days.
