AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, in firearms and other dangerous
- articles, further providing for definitions and for
- 4 possession of firearm by minor.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 6102 of Title 18 of the Pennsylvania
- 8 Consolidated Statutes is amended by adding definitions to read:
- 9 § 6102. Definitions.
- 10 Subject to additional definitions contained in subsequent
- 11 provisions of this subchapter which are applicable to specific
- 12 provisions of this subchapter, the following words and phrases,
- 13 when used in this subchapter shall have, unless the context
- 14 clearly indicates otherwise, the meanings given to them in this
- 15 section:
- 16 "Assault weapon." Any of the following:
- 17 (1) A semiautomatic rifle that has an ability to accept
- 18 a detachable 44 magazine and has at least one of the

- 6 (relating to active duty for emergency).

- 10 "Weapon-carrying officer." A county probation or parole
- 11 officer who is authorized to carry a weapon in connection with
- 12 performance of the duties of the officer's employment.
- 13 Section 2. Section 6110.1 of Title 18 is amended to read:
- 14 § 6110.1. Possession of firearm or assault weapon by minor.
- 15 (a) Firearm.--Except as provided in subsection (b), a person
- 16 under 18 years of age shall not possess or transport a firearm
- 17 anywhere in this Commonwealth.
- 18 (a.1) Assault weapon. -- Except as provided in subsection
- 19 (b.1), a person under 21 years of age shall not purchase,
- 20 possess or transport an assault weapon.
- 21 (b) [Exception] <u>Firearm exception</u>.--Subsection (a) shall not
- 22 apply to a person under 18 years of age:
- 23 (1) who is under the supervision of a parent,
- 24 grandparent, legal guardian or an adult acting with the
- 25 expressed consent of the minor's custodial parent or legal
- 26 quardian and the minor is engaged in lawful activity,
- including safety training, lawful target shooting, engaging
- in an organized competition involving the use of a firearm or
- 29 the firearm is unloaded and the minor is transporting it for
- 30 a lawful purpose; or

- 1 (2) who is lawfully hunting or trapping in accordance
- with 34 Pa.C.S. (relating to game).
- 3 (b.1) Assault weapon exception. -- Subsection (a.1) shall not
- 4 apply to a person under 21 years of age who is:
- 5 (1) a member of the armed services;
- 6 (2) an authorized weapon-carrying officer; or
- 7 <u>(3) a vested peace officer.</u>
- 8 (c) Responsibility of adult. -- Any person who knowingly and
- 9 intentionally delivers or provides to the minor a firearm in
- 10 violation of subsection (a), or to a person under 21 years of
- 11 age an assault weapon in violation of subsection (a.1), commits
- 12 a felony of the third degree.
- 13 (d) Forfeiture. -- Any firearm in the possession of a person
- 14 under 18 years of age or assault weapon in the possession of a
- 15 person under 21 years of age in violation of this section shall
- 16 be promptly seized by the arresting law enforcement officer and
- 17 upon conviction or adjudication of delinquency shall be
- 18 forfeited or, if stolen, returned to the lawful owner.
- 19 Section 3. This act shall take effect in 60 days.
