AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- Consolidated Statutes, in firearms and other dangerous
- articles, providing for report of theft or loss of firearm;
- 4 and imposing penalties.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 18 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding a section to read:
- 9 § 6115.1. Report of theft or loss of firearm.
- 10 (a) Duty to report. -- An owner or other person lawfully in
- 11 possession of a firearm who suffers the loss or theft of a
- 12 firearm shall, within 72 hours of the discovery of the loss or
- 13 theft, report the facts and circumstances of the loss or theft
- 14 to the municipal police of the jurisdiction in which the loss or
- 15 theft is believed to have occurred or the Pennsylvania State
- 16 Police. The person making the report shall provide all known
- 17 information about the firearm, including the following:

- 1 (1) Name and address of the owner.
- 2 (2) All known facts and circumstances pertaining to the
- 3 loss or theft.
- 4 (3) Name of the manufacturer and importer.
- 5 <u>(4)</u> Model.
- 6 <u>(5) Type of action.</u>
- 7 <u>(6) Caliber or gauge.</u>
- 8 <u>(7) Serial number.</u>
- 9 (8) Any other information deemed necessary by the
- officer or police department receiving the report.
- 11 (b) Sharing of information. -- A law enforcement agency that
- 12 receives a report under this section shall, within 24 hours of
- 13 receiving the report, forward notice of the loss or theft as
- 14 well as all information obtained under subsection (a) to the
- 15 Pennsylvania State Police.
- 16 (c) Pennsylvania State Police. -- The Pennsylvania State
- 17 Police shall receive, collect and file the information under
- 18 subsection (a). The Pennsylvania State Police shall cooperate
- 19 and undertake to furnish or make the information available to
- 20 all law enforcement agencies in this Commonwealth for the
- 21 purpose of coordinating law enforcement efforts to locate the
- 22 firearm.
- 23 (d) Return of firearm.--A lost or stolen firearm recovered
- 24 by the Pennsylvania State Police or a local law enforcement
- 25 agency shall be returned to the lawful owner, subject to the
- 26 provisions of section 6111.1(b)(4) (relating to Pennsylvania
- 27 State Police).
- (e) Penalty. -- Notwithstanding any other provision of law, a
- 29 person who violates subsection (a) commits:
- 30 (1) A summary offense for the first offense, punishable

- by a fine of not more than \$500.
- 2 (2) A misdemeanor of the second degree for a second
- 3 <u>offense.</u>
- 4 (3) A misdemeanor of the first degree for a third or
- 5 <u>subsequent offense.</u>
- 6 Section 2. This act shall take effect in 60 days.
