AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in terms and courses of study,
- 6 providing for moment of silence on January 6 anniversary.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- 12 Section 1555. Moment of Silence on January 6 Anniversary.--
- 13 (a) Each school entity shall conduct a moment of silence during
- 14 instructional hours for students and faculty to observe the
- 15 <u>anniversary of January 6, 2021, as a remembrance of the</u>
- 16 individuals who lost their lives or were wounded by
- 17 <u>insurrectionist attacks on that date.</u>
- 18 (b) The Department of Education shall establish a model
- 19 curriculum for instruction in the events and significance of

- 1 January 6, 2021, no later than twelve (12) months after the
- 2 effective date of this section. The model curriculum shall
- 3 include, but not be limited to, all of the following where
- 4 <u>appropriate:</u>
- 5 (1) The historical context of the January 6 attacks.
- 6 (2) The insurrectionist attacks on the United States
- 7 <u>Capitol.</u>
- 8 (3) United States Government response to the attacks.
- 9 <u>(4) Challenges and consequences in a post-January 6 world.</u>
- 10 (c) The Department of Education shall make available on the
- 11 <u>department's publicly accessible Internet website curriculum</u>
- 12 <u>materials and other available resources regarding the events and</u>
- 13 <u>significance of January 6, 2021, for voluntary use by school</u>
- 14 entities.
- (d) Nothing in subsections (b) and (c) shall be construed to
- 16 require a school entity or nonpublic school to implement, adopt
- 17 or use the curriculum, materials and other resources made
- 18 available by the Department of Education under this section.
- 19 (e) For purposes of this section, the term "school entity"
- 20 shall mean a school district, charter school, regional charter
- 21 school, cyber charter school, intermediate unit or area career
- 22 and technical school.
- 23 Section 2. This act shall take effect immediately.
